

ORDINANCE 2008-08
TAX LEVY ORDINANCE

**AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF
LOWER ALLEN TOWNSHIP, CUMBERLAND COUNTY, IN THE
COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX
RATE FOR THE YEAR 2009**

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Board of Commissioners of Lower Allen Township, County of Cumberland, Pennsylvania:

SECTION 1. That the tax be and the same is hereby levied on all real property within the said municipality subject to taxation for the fiscal year 2009 as follows:

Tax rate for general purposes, the sum of 1.50 mills on each Dollar of Assessed Valuation, or the sum of 15.0 cents on each One Hundred Dollars of Assessed Valuation.

The same being summarized in tabular form as follows:

1.50 mills on each Dollar of Assessed Valuation	15.0 cents on each One Hundred Dollars of Assessed Valuation

Tax Rate for General Purposes – 1.50 mills

SECTION 2. Tax rate for Debt Service purposes, the sum of .50 mills on each Dollar of Assessed Valuation, or the sum of 5.0 cents on each One Hundred Dollars of Assessed Valuation.

The same being summarized in tabular form as follows:

.50 mill on each Dollar of Assessed Valuation	5.0 cents on each One Hundred Dollars of Assessed Valuation

Tax Rate for Debt Service purposes - .50 mills

SECTION 3. Tax rate for Fire Services purposes, the sum of .50 mills on each Dollar of

Assessed Valuation, or the sum of 5.0 cents on each One Hundred Dollars of Assessed Valuation.

The same being summarized in tabular form as follows:

.50 mill on each Dollar of Assessed Valuation	5.0 cents on each One Hundred Dollars of Assessed Valuation

Tax Rate for Fire Service purposes - .50 mills

SECTION 4. Rate for street light purposes, where applicable, for fiscal year 2009.

- (a) Township unseated property, 13 cents per foot front
- (b) Township seated property, 52 cents per foot front

SECTION 5. The occupation tax of fifteen (15%) percent or \$.15 on each one (\$1.00) dollar of assessed value of taxable occupation as determined by Article 335 of the Codified Ordinances of Lower Allen Township, 1985, is hereby set for calendar year 2009.

SECTION 6. That any Ordinance or part of any Ordinance, conflicting with this Ordinance be and the same is hereby repealed insofar as the same affects this Ordinance.
